

- The estimated running yield is approximately 5.50%, and estimated yield to call/ maturity is 5.25%, including franking credits. The trading margin for all hybrids is above the 10 year average.
- The total portfolio return was 4.11% for the 12-months to the quarter end including franking credits. Since inception the total portfolio return is 4.60% including franking credits, which is 1.22% above its return objective of the RBA Cash rate plus 3%.
- Last quarter yields on most hybrids were higher, reflecting changes in the interest rate environment.
- The short-dated issue NABPD was called in June 2022 and replaced with a longer dated issue NABPI, as was the Suncorp issue SUNPF, though no replacement was announced. Westpac announced a new issue on 21 June.
- There were no other new issues during the quarter.
- At 30 June 2022 the portfolio had a 1.0% allocation to cash.


